BOGOTA, D.C., COLOMBIA. DECEMBER 22, 2022. CEMEX Latam Holdings, S.A. (CLH) (BVC: CLH) informs that its subsidiary CEMEX Colombia S.A. ("CEMEX Colombia") has declared dividends in favor of all its shareholders, including CLH and Corporación Cementera Latinoamericana, S.L. ("CCL") (a CLH subsidiary), for a total aggregate amount of ONE BILLION FIVE HUNDRED SIXTY-TWO THOUSAND SEVEN HUNDRED THIRTY-TWO MILLION EIGHT HUNDRED NINETY-TWO THOUSAND SEVEN HUNDRED EIGHTY-FIVE PESOS (COP\$1,562,732,892,785), equivalent to approximately THREE HUNDRED TWENTY-FIVE MILLION SEVEN HUNDRED SEVENTY-ONE THOUSAND SIX HUNDRED THREE DOLLARS (USD\$325,771,603), at the exchange rate on the day of the ordinary meeting of the General Shareholders' Meeting of CEMEX Colombia.

Of the total amount of dividends declared by CEMEX Colombia, it correspond to CLH the amount of NINETY THOUSAND NINE HUNDRED THIRTY-FIVE MILLION NINE HUNDRED NINETY-FIVE THOUSAND SIX PESOS (COP\$90,935,995,006), equivalent to approximately EIGHTEEN MILLION NINE HUNDRED FIFTY-SIX THOUSAND SEVEN HUNDRED AND SIXTY AND EIGHT DOLLARS (USD\$18,956,768), at the exchange rate of the day of the ordinary meeting of the General Shareholders' Meeting of CEMEX Colombia, and it correspond to CCL the amount of ONE BILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND EIGHT HUNDRED THIRTEEN MILLION FIVE HUNDRED TWO THOUSAND FOUR HUNDRED SEVENTY PESOS (COP\$1,467,813,502,470), equivalent to approximately THREE HUNDRED FIVE MILLION NINE HUNDRED EIGHTY-FOUR THOUSAND FOUR HUNDRED FORTY-FIVE DOLLARS (USD\$305,984,445), at the exchange rate on the day of the ordinary meeting of the General Shareholders' Meeting of CEMEX Colombia.
